As per notice no.15, dated 16/12/2022, it was informed that admission to B.Sc.Nursing course will be done as per Hon'ble Supreme Court order. Accordingly the Selection list for B.Sc.Nursing CAP Round-2 is declared on 14/01/2023. In view of various applications received from aspiring candidates to allow fresh registration and allow to participate in subsequent rounds of B.Sc.Nursing the competent authority has decided to allow fresh registration to those candidates who failed to registered previously as per schedule given below:

Important Instruction for the Candidates :

- 1) This is One time measure and no further Extension for registration will be given under any circumstances.
- 2) Candidates already registered on the basis of PCB need not registered again.
- 3) All the aspiring candidates for B.Sc.Nursing course will have to register online through the given link on State CET Cell official website **www.mahacet.org** as per the schedule given above.
- 4) Candidates who had registered on State CET Cell website on the basis of NEET UG **will have to Register Again If not registered already** However they have to mention the CET Application Number, NEET Roll Number in the form. **Such candidates need NOT pay the registration fees again.**
- 5) **Candidates who had not registered previously & now wish to participate** on the basis of **HSC (PCB) marks will have to fill the online application** form and make payment of Rs.1000/- as per schedule above.
- 6) There will be Choice / Preference Filling only for newly registered candidates as per above schedule. **There will not be any choice/preference for subsequent round and the same choice/ preference filled during this Round will be used for betterment in subsequent Round(s).**
- 7) Candidates who are allotted a seat in Round-1 on the basis of NEET UG will have to **register again**. Such candidate should fill preference only if they want betterment. If such candidates do not fill choice/preference the seat allotted during the Round-1 will be deemed to be retained.
- 8) Candidates who have registered and filled preference as per Notice No.21 dated 27/12/2022 need not registered and fill preference again.
