However, they will be considered only for newly added colleges only. They will not be considered if they do not add any college.
- Candidates who have Status Retention form can also fill the choice/preference for newly added colleges. However, they will be considered only for newly added colleges only.
- The choice/preference filled in previous CAP round(s) cannot be deleted/ edited/ cancelled.
